Limerick Institute of Technology takes very seriously our obligations to safeguard your personal information. We want to be transparent in how we gather, use and share your data. This Privacy Statement will explain:

1. What Information We Collect about You

The types of information collected and processed by LIT include, but are not limited to, the following:

Contact details: Name, address, telephone numbers, email address, car registration number

Payment details: Bank account details, PPS number

Appointment/Termination of membership: Resignation & appointment letters

Other personal data: CCTV images, photographs, information on directorships, general

correspondence

2. How We Collect Your Personal Data

We collect your personal data at various points in your relationship with LIT. These include the following situations:

- Appointment to and during your period of membership of the Governing Body
- When you use our IT resources
- Where you make your personal data available to us through social media accounts
- CCTV cameras
- Termination of appointment

Any data we collect will be stored securely and treated confidentially. LIT is committed to ensuring that access to your data is limited to those who have a need to process it in line with the purposes set out below.

3. The purpose and legal basis for processing your personal data

We collect and use your personal data for statutory and public interest purposes, including the following:

- to facilitate the operation of the LIT Governing Body
- to process payment for expense claims
- to provide facilities such as IT and car parking
- to comply with our obligations under legislation including taxation, social protection, equality, immigration and health and safety legislation
- to communicate effectively with you by post, email and phone
- to compile statistics and conduct surveys and research for internal and statutory reporting purposes
- to create and publish print and electronic material for promotional, reporting and archival purposes;
- for security purposes (e.g. CCTV footage)

We consider the processing of your personal data for the purposes outlined above to be necessary for the following lawful bases:

- To allow us to comply with legal obligations including those set out in the Institutes of Technology Acts 1992 to 2006; and
- To perform a task carried out in the public interest

There may be other situations where we will be required to seek your consent to our processing of your personal data. You are entitled to withdraw your consent at any time.

4. Who we share your personal data with

Your personal data is held securely by LIT and access is restricted to those staff and Governing Body members, who need the personal data for one of the purposes set out above. We may also share your personal data, where necessary, with the following external organisations:

- **Government Departments:** Revenue Commissioners, Department of Social Protection, Dept. of Public Expenditure and Reform and the Department of Education and Skills
- State Agencies: Higher Education Authority, Payroll Shared Service Centre, An Garda Síochána to assist in the prevention or detection of crime
- **Software Providers**: Software providers or service providers performing administrative functions on behalf of LIT
- Third parties: Prospective and actual research funders or sponsors, Programme validation boards, Mediators and arbitrators, Companies or organisations providing specific services to, or on behalf of LIT; Auditors; Insurance companies in respect of accidents occurring within LIT

5. How long we retain your personal data

We store your personal data for as long as is necessary for the purposes set out above and for at least the duration of your appointment and one year afterwards subject to the fulfilment of your terms of appointment . Our retention schedule is available in the Policy section of the data protection area of our website.

6. Your rights and how to exercise those rights

You have the following rights under data protection law, although your ability to exercise these rights may be subject to certain conditions:

- The right to receive a copy of and/or access the personal data that LIT holds about you, together with other information about our processing of that data;
- The right to request that any inaccurate data that is held about you is corrected and incomplete data updated;
- The right, in certain circumstances, to request that we erase your personal data;
- The right, in certain circumstances, to request that we no longer process your personal data for particular purposes, or to object to our use of your personal data or the way in which we process it;
- The right, in certain circumstances, to transfer your personal data to another organisation;
- The right to object to automated decision making and/or profiling; and
- The right to complain to the Data Protection Commissioner.

7. Where we hold your data

Your personal data will be stored either on LIT premises, with approved storage providers or on secure IT platforms within the EEA. Where your personal data would be held outside the EEA, we will ensure that this is done in accordance with EU approved transfer mechanisms.
